

# Non WHO Reference Material Granulocyte Macrophage Colony Stimulating Factor (Murine rDNA derived)

#### 1. INTENDED USE

#### 2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The preparation contains material of human origin, and either the final product or the source materials, from which it is derived, have been tested and found negative for HBsAg, anti-HIV and HCV RNA. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

## 3. UNITAGE

The assigned potency is 100,000 arbitrary units per ampoule.

## 4. CONTENTS

Country of origin of biological material: United Kingdom. Each ampoule contains the residue after freeze-drying of 1ml of a solution containing:

mGM-CSF approximately 1 microgram 9.0 mg sodium chloride 1.0 mg trehalose 2.0 mg human serum albumin

The murine GM-CSF protein was expressed in E. coli.

## 5. STORAGE

For economy of use, it is recommended that the solution be sub divided into several small aliquots and stored at  $-40^{\circ}$ C or below. Unopened ampoules should be stored at  $-20^{\circ}$ C.

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

# 6. DIRECTIONS FOR OPENING

DIN ampoules have an 'easy-open' coloured stress point, where the narrow ampoule stem joins the wider ampoule body. Various types of ampoule breaker are available commercially. To open the ampoule, tap the ampoule gently to collect material at the bottom (labelled) end and follow manufactures instructions provided with the ampoule breaker.

# 7. USE OF MATERIAL

No attempt should be made to weigh out any portion of the freeze-dried material prior to reconstitution

Dissolve the total contents of the ampoule with 0.5ml of sterile distilled water. Rinse the ampoule with about 0.4ml of sterile distilled water and make up the total volume to 1ml. This solution will contain murine GM-CSF at a concentration of 100,000 units/ml. For further dilution include carrier protein.

# 8. STABILITY

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities and they should be stored on receipt as indicated on the label. An arbitrary unitage was assigned to this

preparation at the time of production without confirmation of long term stability. Evidence from similar materials prepared by an equivalent process indicates that long term stability is likely to be maintained and the material is suitably stable for shipment at ambient temperature without any effect on the assigned values. Once reconstituted, diluted or aliquoted, users should determine the stability of the material according to their own method of preparation, storage and use. Users who have data supporting any deterioration in the characteristics of any reference preparation are encouraged to contact NIBSC.
