Winter respiratory panel: Influenza B
NIBSC code: 20/184
Instructions for use
(Version 2.0, Dated 16/02/2021)

This material is not for in vitro diagnostic use.

1. INTENDED USE

This material is a pre serially diluted panel intended to be run as a complete panel in molecular assays designed for the detection of Influenza B. It must be extracted prior to amplification. Panels contain samples diluted from a high concentration to a low concentration. The material can be used to understand assay sensitivity by end point analysis

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The preparation contains material of human origin, and either the final product or the source materials, from which it is derived, have been tested and found negative for HBsAg, anti-HIV and HCV RNA. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

3. UNITAGE

An arbitrary unit has been assigned to this material. The panel is a serial dilution from the highest concentration in Sample 1 to the lowest concentration in Sample 6. Sample 1 contains 1,000,000 units, Sample 2 100,000 units, Sample 3 10,000 units, Sample 4 1,000 units, Sample 5 100 units and Sample 6 10 units. Sample 7 is a negative control and should not give any signal.

4. CONTENTS

Country of origin of biological material: United Kingdom.
This panel comprises 7 samples. Samples 1-6 are a serial dilution of a cultured strain of Influenza B (Jiangsu). All dilutions have been performed in PBS. Sample 7 is a negative PBS sample. The cultured material has been inactivated using heat and efficacy has been proven via further culture methods. This material is therefore provided as a non infectious panel.

5. STORAGE

This panel should be stored at -20C or below (preferably -70C if available) upon receipt and continue to be stored at that temperature until use

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

6. DIRECTIONS FOR OPENING

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.

7. USE OF MATERIAL

No attempt should be made to weigh out any portion of the freeze-dried material prior to reconstitution

This material is intended to be thawed and directly extracted, no further manipulation is required.

8. STABILITY

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label. This material has been demonstrated to be stable when left at +4C for 24hrs.
